

Parents should know

- Head Teachers are no longer able to authorise absence for holidays during term time. Holidays must be booked during school holiday periods. Absence during term time is unauthorised and used as evidence in cases of prosecutions due to non-attendance.
- Persistent poor punctuality can affect attendance and provide evidence for cases for prosecution.
- If a student is excluded, they should remain at home during the school day.
- Pupils missing for 5 consecutive days can be fined £80 per parent.
- Pupils missing for 21 consecutive days risk being removed from roll at Holly Lodge and would need to find a new school.
- Local authorities may prosecute parents of students found in a public place during school hours after being excluded from school. **The fine is up to £1,000.**

Punctuality

- Students are required to be in form class at 8:45am.
- Any students who arrive after 8:45am (without medical evidence of an appointment) will be marked as late on the register.
- If a student arrives late into school they will be asked to attend a lunch time detention that day.
- If a student fails to attend the lunch time detention, they will be required to attend the detention the next day, failure to attend on 3 occasions will result in a Friday 1 hour detention.

Leave of absence requests

Parents **do not** have a right to take their children on holiday during term time, and maybe fined for taking holidays without schools consent.

Any request for holiday/leave of absence should be completed in writing on a leave of absence request form which can be collected from the school office. This request should be made **at least 10 days** before the first day of absence.

Leave will only be authorised in exceptional circumstances.

Exceptional circumstances **do not include** family holidays, visiting relatives or friends, attending sporting activities, looking after family members, birthdays, shopping etc.

Legislation and Guidance

The Department for Education states that: Parents of compulsory school age children have a legal duty to ensure their children receive a suitable education.

A parent who knows that their child is failing to attend school regularly and fails to cause the child to do so, is guilty of an offence.

(Education Act 1996, s444)

Costs of non-attendance

A parent who fails without reasonable justification to ensure their child attends school can be taken to court and prosecuted.

On conviction, the parent may be liable to:

A fine of up to £2500;

Imprisonment up to three months;

Or both.

Holly Lodge School will make referrals to the Attendance and Prosecution Service if students do not attend school regularly.

As a school we expect parents to:

- Ensure their children attend school on time every day;
- Telephone school on the first day of absence;
- Try and make medical or dental appointments outside of school hours;
- Not take children out of school during term time for holidays or visits;
- Notify school if problems arise with attendance;
- Encourage children to report any issues to staff immediately;
- Encourage children to attend and engage with school and make the most of their educational opportunities.

As a school we expect students to:

- Arrive in school in time for registration - before 8.45;
- Be on time for all lessons;
- Bring in a note from parent or carer to explain absences;
- Report any problems with attending school to a member of staff - Form Tutor, Head of Year, Student Support Manager, Attendance Manager, - who can offer them support.

As a school, parents and students can expect us to:

- Support students and parents to encourage good levels of attendance;
- Promptly resolve any issues or problems that may arise and affect attendance;
- Regularly praise high levels of attendance through form groups and assemblies;
- Offer a prize draw reward at the end of each year for excellent attendance.

Attendance

Minimum expectation for attendance is 95%

Persistent absence (below 90%) parents could be at risk of prosecution.

90% Attendance over 1 school year is a total of 4 weeks missed learning.

Why should you attend school regularly?

- Achievement is seriously affected by poor attendance. Of students who miss between 10% and 20% of school, only 35% achieve a grade 5 to 9 at GCSE.
- To start building good habits of reliability and timekeeping needed for future study and employment.
- Parents have a legal responsibility to ensure their child attends school.
- Holly Lodge refers parents to the local authority attendance and prosecution service if they fail to ensure their child attends school regularly.

What absences will school authorise?

- Genuine illness (you may be asked to provide medical evidence).
- Medical/dental appointments. Evidence will be required in order to authorise the absence.
- Interviews.
- One day for religious observance.
- Court Appearances.
